Minutes of Business Meeting –April 1, 2011**

The meeting was called to order at 10:15 AM following the presentation, "Electric Industry 101", provided by Tim Bunkers, Universal Field Services.

Introductions of meeting attendees started the business meeting with 23 members in attendance.

Secretary's Report: The minutes from the January 7, 2011 business meeting held at Universal Field Services in Urbandale, Iowa, were reviewed. A reminder the minutes are posted on the IRWA, Chapter 41 website for review prior to the business meeting. A motion was made to approve the minutes as published. The motion was seconded and approved by all members present.

Treasurer's Report: The Treasurer's report was provided and showed a current balance of \$8,605.72. A copy of the report is also available to review in the latest edition of the "Chapter 41 Update". A motion was made to approve the Treasurer's Report as presented; the motion was seconded and approved by all.

Committee Reports:

There was a question if the 77 includes Tylor Mann, which we will check and report back. Nancy Halvorson raised the question about how many retired members didn't renew their membership this year. We will also check and provide more information at the next meeting.

Professional Development Committee: PDC Chair Joe Anderson presented Chad Johnson with his SR/WA pin and plaque. Congratulations Chad!

Joe also noted there are currently six candidates for SR/WA and two candidates for R/W-NAC certifications.

Other Committees:

Utility Committee: Dave Hingtgen reported he spent two days in Chicago where they discussed certifications and the possibility of adding or eliminating them all together. He is still waiting for the final report from the meetings.

International Nominations and Elections Committee: Nancy Halvorson reported that the awards at the annual conference will be presented differently this year. It is now going to be a surprise to the award winner at the conference rather than being notified prior to the conference. All finalists will be notified and invited to attend the luncheon where the winner will be announced. Nancy did announce our Newsletter is a finalist for Newsletter of the Year!


Nancy announced there will be a new award in memory of Howard Armstrong which will be a recognition for outstanding facilitators. She also stressed we should nominate our Chapter in the small chapter category (under 100 members) as the winner receives a \$500.00 award to the Chapter. There were no nominations this year in this category. We also need to submit a Balfour candidate.

50th Anniversary 2013: We are planning to hold the 50th Anniversary of our Chapter around the Spring Forum in 2013. A committee needs to be formed to help decide how big and what type of event to hold. It was decided that the Nebraska Chapter will be contacted to see if they would like to be a part of the celebration since we were originally formed as one chapter. Approval of Directors: The following slate of Directors was presented and voted favorably:

Approval of Directors Funding for Atlanta: A number of members are planning on attending the Atlanta Annual Conference and Tim Bunkers will be a Director with Ken Wunsch or Vicky Kitelinger as Alternate. It was voted favorably to fund up to \$1,500 of expenses for Vicky Kitelinger if her employer does not participate in funding. Tim Bunkers and Ken Wunsch are funded by their employer, Universal Field Services, to attend. Directors were reminded they must attend the Board of Directors meeting on Wednesday afternoon. They will also be voting for IEC Secretary, a Resolution to approve the proposed rotation through each Region as hosts for the annual conference, and voting for the location of the 2016 conference with the choices being Nashville, Virginia Beach and Omaha. If the Resolution is approved and Omaha is not chosen for 2016, then our Region will be the first up to host in 2017.

If you are planning on attending the conference you are asked to assist with the Omaha Booth to help promote Omaha as a worthy conference location. This is a Regional effort to showcase the heartland!

Donations—Golf hole/Auction: It was announced there will not be an auction at this year’s annual conference. Instead, it was decided to hold a Casino Night as the fundraiser for the Education Foundation. There will still be a few specialty items available for auction. The Regions were asked to participate in a vacation package that will be raffled off. The vacation packages will be prepared by IRWA and are estimated to be valued at \$1,500 each. The golf tournament is still being held as it has in previous years. It was voted and approved to donate \$300 towards the sponsorship of a hole during the tournament. It was also voted that we will donate up to \$300 towards the vacation raffle pending the outcome of the rest of the Region’s decision to participate. There are some chapters considering their participation in this event.

Installation Banquet in June: Tim Bunkers requested input for a date and location. It was decided either June 4th or June 25th with the location still to be determined. Stay tuned for more details...

Region Forum Report from Deadwood: Guess what....it Snowed at the Spring Forum on March 3rd in Deadwood! Rita Rasmussen reported there was a good turnout and they really had a good time. Chapter 72 held a Mardi Gras themed welcome reception and raised around \$5,000 at their auction. There were 40 attendees at the Region Forum. We are reminded to promote the online courses as the Chapter receives \$50 for every online registration. It was voted on and favorably approved to reimburse Don Corrigan an additional \$167.50 for his expenses in attending the Forum.

Fall Forum is scheduled for October 13-14, 2011 at the Radisson Mall of America Hotel in Bloomington, MN. You are encouraged to make your room reservation soon to get the block rate.

Dual Signature of Checks—Annual Budget: The President and Treasurer need dual signature on checks or approval by the President in writing before a check is issued. Tim Bunkers will create an approval form and process to set up a paper trail for auditing purposes.

The IEC is requiring an annual budget. Tim Bunkers will put together a Budget/Audit Committee.

Adjourn: A motion was made and seconded and approved by all to adjourn the meeting at 11:50am.
